B. BOARD COMMENTS:

Stu Davies:

Served on the Board of Agriculture and Conservation under three governors. I have an idea of what the board is supposed to do.

The Agriculture Loan Act was passed in 1953, prior to statehood.

There is statutory and regulatory authority vested in the board.

Vision: Pay for staff to run program from ARLF income – put those \$ back in the DNR budget. Wants permanent staff back ASAP!

Jeff Vance: Don't need change How do we grow loans 990 farms and only 55 farms

John Anderson: Want to see a plan of action prior to staff. Need to do farm development loans How do we have results: what are the benchmarks? Amanda Swanson: (Chair Davies asked Amanda her thoughts) Fund needs updating of processes and/or requirements i.e. 75 % equity ratio – new farmers don't have the 25% to put down. Regulations need updating for operating loans Should consider setting up line of credit for farmers – 5 year duration.

Stu Davies: Loan Applications are cumbersome.

T.J. Heider: Agree with above comments. 25% Line of Credit Streamlining process Confidential information

Stu Davies: Ag Covenants (restrictions) need modified Need smaller than 40 acres

Promoting land sales important. Sat down with staff – Moe . Found no webpage or source for finding Agriculture related land.

Believes we should consolidate information about lands known for Agricultural value.

C. PUBLIC COMMENTS:

Sabrina Holland: Local Vet and community member No criticism: ARLF makes \$ - she has two loans Some procedural problems when she wanted to expand her vet business on an ag parcel.

Use Facebook for public notice/information. Time is an issue for people on the farm/ranch. Mail is a waste of \$.
