Alaska Association of Conservation Districts Request for ProposalsAlaska Invasive Plants Program Grant

The Alaska Association of Conservation Districts (AACD) is now accepting grant applications for invasive plant management projects across Alaska. AACD has a total of \$70,000 available to be distributed through CWMAs, SWCDs, nonprofits, local communities, and Alaska Native organizations for the 2016 field season.

The purpose of the Invasive Plants Program Grant (IPP) is to support quick and effective responses to invasive plant infestations in Alaska by supplementing local funds and resources for invasive plant efforts related to survey and management. Projects should be modeled using the principles of early detection - rapid response (EDRR).

- Proposals are due by 5pm, February 3, 2016.
- Most projects are \$1,000-\$10,000 in scope, and all non-federal organizations are welcome to apply.
- Applicants that can provide non-federal matching funds will be given preference.
- Projects targeting species ranked 60 or greater by the Alaska Natural Heritage Program will receive preferential consideration, (<u>aknhp.uaa.alaska.edu/botany/akepic/non-native-plant-species-list/#content</u>).
- Funds may not be used to control invasive weeds on federal or agricultural lands.
- Funds may not be used for aquatic weed control.
- This is a competitive grant process where proposals are reviewed and ranked by professionals employed at organizations such as UAF Cooperative Extension Service, Alaska DNR, and/or AACD.

Invasive Species Council of British Columbia Launches PlantWise Website




PlantWise is a provincial program that supports the (ornamental) horticulture industry's transition to become invasive-free, and is helping gardeners and industry understand which plants are invasive and harmful

to our communities, and to make 'PlantWise' choices. To achieve these goals, ISCBC works collaboratively with plant growers, retailers, specifiers, and landscapers across BC.

Together we are making a difference!

In 2014 the PlantWise message was shared at 244 education and outreach events in 78 communities across BC. Approximately 5812 in-person PlantWise interactions were completed by ISCBC staff and PlantWise Ambassadors, resulting in 1410 verbal and 982 written commitments. National Forest Foundation Announces 2015 Tongass Capacity-Building Grant Opportunity

In partnership with the U.S. Forest Service Alaska Region, the National Forest Foundation is pleased to announce the fourth year of its capacity-building funding funding program to benefit the Tongass National Forests and the communities that depend on it.

The Community Capacity and Land Stewardship (CCLS) grant program provides grants of \$5,000 to \$24,000 to enable community-based organizations and collaborative groups to increase their capacity to facilitate and/or implement watershed or landscape-level restoration projects. The program also seeks to help meet job creation and business development objectives, and advance the transition to young growth-based forest management. Grants will be awarded for a period of one year.

Work may take place on or off of the Tongass National Forest, but there must be a clear, direct benefit to its watersheds. Organizations are not required to match CCLS award funds, but are encouraged to leverage additional private and local, state, or governmental resources to show broad support for the project.

Proposals are submitted via online application and are due on or before March 25th . Please review program guidelines and application details at https://www.nationalforests.org/ grant-programs/ccls.
