# Federal Overreach Summit - Developing Strategies to Improve Alaska's Relationship with the Federal Government

The Citizens' Advisory Commission on Federal Areas is sponsoring a <u>Federal Overreach Summit</u> at the Dena'ina Center, 600 West 7<sup>th</sup> Avenue, Anchorage on Monday, August 12 from 8 a.m. to 5 p.m. and continuing on Tuesday, August 13 from 8 a.m. to 5 p.m.

The agenda will include presentations by State and Congressional leaders as well as individuals with extensive histories and diverse professional experiences to discuss, document, and raise awareness of Alaska's relationship with Federal land and resource management agencies. The ultimate goal is to develop a collaborative, and effective action plan that can be implemented by the State Legislature, our Congressional delegation and the Governor.

The Summit will: Examine the promises made to Alaska at Statehood; present examples of how those promises have not been honored by the Federal Government; discuss the impacts of critical laws such as the Alaska Native Claims Settlement Act, Alaska National Interest Lands Conservation Act and the Endangered Species Act; lay the groundwork for developing achievable State and Congressional policy initiatives to reverse Federal actions that infringe on Alaska's sovereign right to manage and utilize its lands, waters and wildlife resources in a responsible and productive manner; and forge a coalition of individuals, organizations, agencies, and companies who can continue the work.

<u>The meeting is free and open to the public.</u> You should consider attending if you are increasingly troubled about the patterns of Federal overreach in Alaska, are interested in finding workable solutions to these problems and want to 'Stand With Alaska' and other Alaskans to protect our Sovereign rights.
