Governor Parnell Submits ANWR Plan

"The 1002 Area of ANWR holds enormous promise for Alaska and for our nation," Governor Parnell said. "Federal law provides clear direction and mandates a number of actions that the Interior Secretary must take upon the submission of a 1002 Area exploration plan. We look forward to Interior Secretary Sally Jewell's prompt review and approval of this exploration plan."

On May 18, with support from North Slope Borough Mayor Charlotte Brower and Arctic Slope Regional Corporation President and Chief Executive Officer Rex Rock, the State of Alaska submitted a detailed 1002 Area exploration proposal and offered to help finance seismic studies in the 1002 Area. In late June, Interior Secretary Sally Jewell completely rejected the State's proposal and offer of funding support. Therefore, the State is submitting a formal 1002 Area.

The exploration plan and accompanying special permit application builds upon the detailed proposal the State submitted in May. The plan will take advantage of current technology, which will have significantly less environmental impacts than the exploration activities approved and conducted in the 1002 Area during the 1980s.

The 1002 Area is thought to be one of the most prolific regions for undiscovered oil in America. The State seeks to conduct low-impact, three-dimensional surveys across the 1002 Area from 2014 to 2017. This work will only be done during the winter, with very limited impact to tundra, fish and wildlife.

"I am renewing my pledge to seek support from the Alaska Legislature during its 2014 session to fund a 3-D seismic program for the 1002 Area," Governor Parnell said. 

NPS to Issue Certificate of Access for **Chandler Lake Clean-up**

The National Park Service (NPS) will be issuing a right-of-way certificate of access (RWCA) to Ms. Mabel Burris of Anaktuvuk Pass for access through Gates of the Arctic National Park to her Native allotment to base activities for removal of abandoned Department of Defense (DOD) debris from lands owned by the Arctic Slope Regional Corporation and individual Alaskan natives around the Chandler Lakes area within park boundaries. An environmental assessment (EA) was prepared to evaluate potential impacts to cultural and natural resources associated with the proposed access project, a no-action alternative and a third alternative. The completed application

for access from Ms. Burris requested permits to authorize two 8-wheeled Argo all-terrain vehicles to travel over NPS lands between Anaktuvuk Pass Village and the Burris allotment and project cleanup sites in the area during the summers of 2013 and 2014. Other members of clean-up crews will fly to base camp at the Burris allotment on Little Chandler Lake from which to stock-pile and bundle debris at seven sites in the area. Bundles of debris will be removed by snowmobiles and sleds across NPS lands during spring of 2014



and 2015. The project is funded by the Native American Land Environmental Mitigation Program through a cooperative agreement (CA) between DOD and the village of Anaktuvuk Pass, a federally recognized Alaska Native tribe. The NPS selected Alternative 2, which is the NPS Preferred Alternative in the EA. This alternative allows for the most economical access and provides for contingency trips for emergency.

Detecting changes in climate will inform managers about a broad range of resource effects including glacial ice mass wasting, shifts in marine salinicommunity advance, spread of invasive species, and adjusting park infrastructure to more intense storm events or rising sea levels.

Comment Period Extended for **NPS Draft Land Protection Plans**

The National Park Service is extending the public comment period for draft land protection plans for Lake Clark National Park & Preserve, and Gates of the Arctic National Park & Preserve. The plans are open for public comment through August 12.

Land protection plans are required for all National Park System areas that contain private or nonfederal lands or interests within their boundary. The plan articulates what lands or interests in land the park may have and what means of protection are available to achieve the purposes for which the unit was created. A land protection plan is not an offer to purchase land, nor does it diminish the rights of non-federal landowners. The plan is intended to guide the park's land protection activities subject to the availability of funds and other constraints.

Most Alaska parks developed a land protection plan in the mid-1980s as part of their broader general management plans, although Lake Clark did not have such a plan. Most Alaska parks, including Gates of the Arctic and Lake Clark, have a significant amount of non-federal land within their boundaries.

The Council was formed in February 2010, to provide advice about wildlife and habitat conservation endeavors that: benefit wildlife resources; encourage partnership among the public, sporting conservation organizations, States, Native American tribes, and the Federal Government; and benefit recreational hunting. The Council advises the Secretary of the Interior and the Secretary of Agriculture, reporting through the Director, USFWS, in consultation with the Directors of the BLM and the National Park Service; the Chief Officers of the USFS and NRCS and the Administrator for the Farm Services Agency.
