

**SUPPLEMENTAL NOTICE REGARDING
PROPOSED CHANGES IN THE
REGULATIONS OF THE DEPARTMENT OF NATURAL RESOURCES**

This is a supplement to the public notice issued on October 12, 2007 by the Department of Natural Resources (DNR) regarding its proposal to adopt regulation changes in Title 11 of the Alaska Administrative Code (AAC), specifically 11 AAC 96.10 dealing with the Uses Requiring a Permit, 11 AAC 96.14 dealing with the Special Use Lands, 11 AAC 96.18 dealing with the Uses Requiring Registration, 11 AAC 96.20 dealing with the Generally Allowed Uses and the proposal to adopt new regulations in Title 11, of the Alaska Administrative Code, specifically 11 AAC 96.015 dealing with the Designated public use areas.

PUBLIC MEETING

DNR has received requests for additional information and to hold a public meeting on these proposed regulations. In order to address these concerns, DNR has scheduled a public meeting to present information and facts regarding these proposed regulation changes and to answer questions. The meeting will be held in:

DNR will first be presenting a power point presentation on the need and purpose behind the proposed regulations which will be followed by a question and answer session. This meeting is not intended as a workshop for discussion or planning purposes, nor is it intended to be a public hearing. DNR will not be accepting *oral* testimony or comments. The department will, however accept written comments at the meeting.

EXTENSION OF COMMENT PERIOD

The original comment deadline was 5:00 p.m., Friday November 16, 2007. To facilitate the public meeting, this notice extends the public's deadline for comments to 5:00 p.m., November 23, 2007. No changes have been made to the proposed regulations.
