## NOTICE OF PROPOSED CHANGES IN COAL MINING IN THE REGULATIONS OF THE DEPARTMENT OF NATURAL RESOURCES

The Department of Natural Resources (the Department) proposes to amend regulations in Title 11 of the Alaska Administrative Code which governs Alaska's Alaska Surface Coal Mining Program. These revisions will implement program amendments throughout chapter 90 from the federal Office of Surface Mining Reclamation and Enforcement (OSMRE) required to maintain the state's control over the coal program. Substantive amendments include changes to the information required from an applicant regarding ownership and control of a mining operation, and updates to the process for determining valid existing rights to coal resources on certain state and federal land (e.g., national forest and park lands).

Additionally, the Department will readopt all sections within 11 AAC 90.002 – 11 AAC 90.911 into the Alaska Administrative Code (AAC). As a result, regulations will no longer be adopted by reference in 11 AAC 90.001(a) as a separate document prepared and retained by the Department but instead will be printed in full in the AAC. Most sections are proposed for readoption without change, aside from possible technical amendments after the public comment period or resulting from Department of Law review:

This notice will include a copy of the regulations that will be readopted into code as well as copies of substantial amendments to ownership and control and valid existing rights regulations for review. Please see below for where to find copies of regulation codification and amendments and for how to comment.

Proposed substantive changes include the following:

- (1) 11 AAC 90.001 Adoption by reference;
- (2) 11 AAC 90.023 Identification of interests and compliance information;
- (3) 11 AAC 90.025 Authority to enter and ownership information;
- (4) 11 AAC 90.119 Transfer, sale, or assignment of permit rights;
- (5) 11 AAC 90.121 Areas where mining may be limited;
- (6) 11 AAC 90.123 Valid existing rights;
- (7) 11 AAC 90.125 Commissioner's findings;
- (8) 11 AAC 90.127 Areas unsuitable for mining;
- (9) 11 AAC 90.163 Exploration that substantially disturbs the natural land surface or occurs in an area designated unsuitable for surface coal mining;
- (10) 11 AAC 90.613 Cessation orders;
- (11) 11 AAC 90.617 Suspension or revocation of permits;
- (12) 11 AAC 90.625 Penalty assessment and computation;
- (13) 11 AAC 90.637 Amount of individual civil penalty;
- (14) 11 AAC 90.911 Definitions; and
- (15) Conforming changes to any Title 11 regulations to cite any new regulations as addressed in the items above.

And inserting new sections relating to the following subject areas:

(1) Entry of information into the applicant violator system;

- (2) Permit eligibility determination;
- (3) Review of application information to determine eligibility;
- (4) Provisional permits;
- (5) Updating, correcting, or indicating no change on information previously submitted by an applicant;
- (6) Areas designated by acts of Congress;
- (7) Processing a request for valid existing rights;
- (8) Initial review of preliminary finding requirements for improvidently issued permits;
- (9) Notice and appeal requirements for the proposed suspension or rescission of an improvidently issued permit;
- (10) Suspension or rescission requirements for improvidently issued permits;
- (11) Ownership or control challenges;
- (12) Post-permit issuance information requirements for permittees;
- (13) Lands eligible for remining;
- (14) Criminal penalties;
- (15) Civil actions for relief; and
- (16) Contractor eligibility.

The comments must be received by the Department no later than 5:00 p.m. on March 11, 2022. All comments received become public records that are subject to public inspection.

You may submit written questions relevant to the proposed action to the contact information provided above. Questions must be received at least 10 days before the end of the public comment period (by March 1, 2022). The Department will aggregate its response to substantially similar questions and make the questions and responses available on the Alaska Online Public Notice System at <a href="https://dnr.alaska.gov/mlw/news/">https://dnr.alaska.gov/mlw/news/</a>.
