If this is not known, provide road names and mileage markers, waterway names, and other locatable descriptions. Provide a marked USGS map if needed for clarity of location.
3. For each harvest location, specify how much of the given product was harvested.
4. Specify the dates on which the reported amount of product was taken from the specific location.
5. Amounts and products taken in excess of the original authorization will be billed to the permit holder. No refunds are given for harvest amounts below the original authorization.
