RECORDABLE DISCLAIMER OF INTEREST

Serial No. AA-94268

WHEREAS, the State of Alaska is entitled to a recordable disclaimer of interest pursuant to Section 315(a) of the Federal Land Policy and Management Act of October 21, 1976, 43 U.S.C. 1745(a), the United States of America, acting by and through the Bureau of Land Management – Alaska State Director, hereby gives notice that the United States claims no real property interest in the lands underlying the water body comprising the Taku River, and therefore disclaims any and all real property interest in the submerged lands more particularly described as:

The submerged lands between the ordinary high water lines of the left and right banks of the Taku River, beginning at the 60-foot boundary reserve within sections 10, 11 and 14, township 38 south, range 71 east, Copper River Meridian, Alaska, to the extent of tidal influence, regardless of location.

This disclaimer is subject to all valid existing rights, if any.
