Re: Bristol Bay Area Plan – Additional Community Meetings <u>UPDATE</u>

Dear Alaskan,

The Department of Natural Resources (DNR), has **extended the public comment period** for the Public Review Draft (PRD) of the Determination of Reclassification and Plan Amendment to the 2005 Bristol Bay Area Plan (2005 BBAP) for an additional 30 days until **May 6, 2013** to provide the public with a greater opportunity to review and comment on the PRD.

The state would like to hear from the public regarding these actions. To facilitate this, DNR will host a series of community meetings to discuss the issues addressed through these two actions, explain the review and approval processes for these actions, and indicate the how and when comments are to be submitted to DNR. There will be the opportunity for the public to ask questions and provide comment.
