



Subj: Replat in the Unorganized Borough

Dear Petitioner:

Your letter dated _____ requesting the **Replat** located within Section (s) _____, Township _____, Range _____, _____ Meridian has been received by this office. This letter outlines the process to request approval of the vacation by DNR.

I. PETITION:

- A. A petition form completed by the petitioner or his/her representative containing the signatures of the landowners directly affected must be submitted. (One copy of the petition form is enclosed with this letter.)
- B. Obtain the names and mailing addresses of all property owners within 500 feet of the petitioned area, including local utility companies and Native Corporation landowners if applicable.
- C. **Required Submittal:**
In addition to A and B above, obtain or prepare a map or plat of the area showing the following information:
 1. The subdivision plat with the petitioned vacation or replat action clearly indicated.
 2. Current property boundaries, existing and dedicated rights-of-way and easements within 500 feet.
 3. If the petitioned action is for the vacation of a platted right-of-way, equal or better access will be required under AS 40.15.300.
- D. Mail the above information, including a check for the application filing fee to the Survey Section; Division of Mining, Land, & Water; 550 W 7th Avenue, Suit 650; Anchorage, Alaska 99501-3576.

II. APPLICATION/SURVEY INSTRUCTION FEE AND ADVERTISING COST:

The petitioner must pay the application/survey instruction fee and the cost of advertising the public notice. The petition must be accompanied by a check for \$50 for the application/survey instruction fee, made payable to the Alaska Department of Natural

Resources. After the department verifies the cost to advertise the public notice in a newspaper, you will be notified and must then submit to this office a check made payable to the Alaska Department of Natural Resources.

III. STATE ACTION:

The DNR Survey Unit will review the petition for completeness and verify the state's jurisdiction under AS 40.15.305(e) for this area, and that fees and costs have been paid. Then a public hearing will be scheduled, to be held not less than 30 days or more than 60 days following that date. After a minimum of 30 days following the public hearing, the Director of the Division of Mining, Land & Water will approve or disapprove the petition.

IV. SURVEY PLAT AND REVIEW FEES:

A. If the petition is approved, at the petitioner's expense a survey plat in accordance with the provisions of AS 40.15.300 through .380 and 11 AAC 53.600 through .740 must be prepared by an Alaska Registered Land Surveyor and submitted for review and approval.

2. **Replats** of existing subdivisions are \$400.00 for the first parcel and \$100.00 for each additional parcel.
3. The recording fee is \$20.00 for the first sheet plus \$5.00 per each additional sheet.

B. The petition approval becomes null and void if a survey plat is not submitted and recorded within 18 months of the platting resolution approval date.
