This order takes effect May 15, 2014, and supersedes fees for reserved use of public use cabins described in Director's Order #251 dated June 1, 2010.

Under authority of 11 AAC 05.010 (a) (12), the fee for reserved use of the following public use cabins is as follows:

Reservations are from noon to noon. A change to or cancellation of a reservation for a Public Use Cabin or Ice Fishing Hut must be done at least 48 hours in advance of the start of the reservation in order for the customer to receive a credit.

Changes or cancellation can be done by phone or in person. If making a change or cancellation by phone, the cabin reservation number must be provided. If done in person, the original reservation must be presented. If the cancellation or change of a cabin reservation is due to a family emergency or severe weather conditions, the 48 hour notification requirement may be waived. Otherwise, without the 48 hour notification, a reservation cannot be cancelled or changed and a credit issued.

Credits are good for one year from date of issue, can be used one time only and must be presented when making a new reservation.
