These trails must have **established legal access** and must have been **previously funded.** Trails outside of the established grooming pool are not eligible for funding through the submission of this form. Additional trails to be added to the grooming pool must go through the Snowmobile Trail Grant application process. Section 3: Experience

If there are multiple funding requests for the same grooming area, and a compromise cannot be achieved, the Request For Proposal (RFP) process will be implemented through the State of Alaska Procurement office, and all competing applicants will be required to go through this competitive bidding process. In these cases, DNR will notify all competing applicants and assist them in the process. To accommodate the potential for competitive bids, applications must be received no later than **July 1 at 5:00 pm**.

Grooming Pool Funding Request forms will be reviewed by the Snowmobile Trails Advisory Council (SnowTRAC) and DPOR staff during August at the SnowTRAC annual meeting. All requests will be reviewed and funding recommendations will be made. The final funding appropriation may not reflect the request in this form. Several factors including available funds, public demand, legal access, maintenance costs, recreational value of the trail, transportation benefit etc. will determine the final funding amounts for the Grooming Pool Trail System.

PLEASE TAKE NOTE:

- *Funds for winter trail maintenance and grooming activities will be available no earlier than October 15th.
- *Periodic trail evaluations will be conducted throughout the season to ensure compliance with specifications outlined in grooming contract.
- *Monthly Reporting will now be required whether you have groomed or not. All reimbursement requests must be turned in by April 30.
- *Please check the name and address for sending your reports, it may have changed since last year.
