**1. Call to Order**

**4. Committee Reports**

**a. State Parks-Jack Blackwell**

1. Ricky and I met with the Seldovia community last week and discussed the concept of reopening the roads to Windy Bay and Red Mountain. The administration is forming a working group to evaluate tourism opportunities across the state, and these roads could potentially fit in that effort. These were very preliminary meetings and additional discussions are necessary with Port Graham.
2. Nothing new to report on the management plan revision. We are waiting for the commissioner to decide on the appeals.
3. We continue to work with HEA on a long-term solution to the powerline flooding issue at Stonehocker Creek.
4. The division recently held a teleconference with advisory board chairs across the state.

**b. Operations Report-Jason Okuly**

1. Dimond Creek’s road and trail was heavily damaged by the flood event in December. It is unknown if the gate will be opened in the spring after breakup due to the poor condition of the road.
2. Free Range Grazing was happening in the Park by Cottonwood Eastland. Contact was made with the individual responsible for the grazing and voluntary compliance was achieved.
3. Helped with grooming at Eveline for the first day hike.

4. John Sharp Questions attached Alaska Yurt Rentals End of Season Report specifically dealing with management issues or suggestions. Would like to see Yurts Management under New Business for next meeting.
