7. Committee Reports

a. Operations Report- Roger MacCampbell spent the day with Eric Clarke, Libby Bushnell and Bob Hickman at Kachemak Crack. It was determine that they will be closing the climbing area at Kachemak Crack and will be reestablishing 1 group camp site and 2 other regular camp sites on left beach. Libby Bushnell from HOWL will be doing the work. They are plan on starting phase one the weekend of May 12.

A field inspection was conducted in establishing the new location for the Halibut Cove Net Pens. A the new landing craft there were 2 representatives from Cook Inlet Aquaculture, 2 from Alaska Department of Fish and Game, and State Park representatives Jack Sinclair, Pam Russell and Roger MacCampbell. The location of interest was between Hawaii Beach and the darlings. The depth in this area is approximately 60 feet and is located away from the oyster farms. The team also looked at sites outside the park between two oyster farms, the only objection to this was that it was considered a mixing zone for native and wild fish. We are currently waiting for the director's determination and the permit approval. The permit will only be issued for 1 year.

Roger had two meeting with the water trails group at Island and Oceans. There was also a public meeting at Seldovia. The community is in full support of developing the trails and also working on the trail from Rocky River Road to the Tutka Bay hatchery. The trail is established, it just needs some signage and possible brush clearing work.

All ACC staff and paid staff are all on board for the summer. Roger has had several staff meeting.

Roger attending the Homer Cycling club meeting. The organization in gaining support for developing trails in the park. There is support of trail development for fat tires use seasonally on specifically on certain trails. They are also working on developing a trail at Cottonwood Eastland is favored for seasonally use.

Eric Clarke has been doing site inspections of public use cabins and yurts. The latrine in the Halibut Lagoon has been pumped out. The ramp is in the lagoon. The crew helps with hazard tree removal at Ninilchik SRA and Bob Hickman was in Boat operator training. He is now a certified boat operator after the training. The Tutka Bay campsite is currently closed due to a tree hazard. There are sign posted. Eric went to a two day trails and all the boats are in the water and operational. Dimond creek borough hazard trees and mitigation and this is the last year of funding. Surveying north boundary 100 or 150 of all spruce bark beetle kill. Will some be left for wildlife and Roger said yes. Give the firewood away for free. Eric Clarke sent out a trail report, trails that are open at this time are, Saddle and Grewingk

b. Friend's Report-Mako sent letters to the local grocery stores for donation for the Shorebird pancake break. Both Safeway and Save U More will be donating items. Mako ordered the sausage for the breakfast. Tickets have been made, cut and number and ready for sale by all the board members. Presale of the tickets if the key to success for this breakfast.
