

NEW BUSINESS

- A. First Day Hike Debrief: Teri commented on the good turnout, she estimated around 50 people showed up for some part of the event. The fire was noted as an important part of the event, giving people a central place to meet and stay warm after the polar plunge. Leslie noted on the diversity of attendees. Overall the event was viewed as a success. Teri suggested having the event at Refuge Cove again because of the park's location and swimming beaches.
- B. LIO Contact and Priority List Discussion: Leslie noted the justifiable use of CPV funds for Totem Bight differed maintenance projects due to the impact the cruise industry has on the park. There was a discussion about how these funds should be used to support existing and proven parks and facilities used by visitors and tour companies, instead of investing in new local parks. There was further discussion regarding the Boroughs use of CPV funds and the potential for community grants in the future if the Ward Cove cruise ship terminal is built, resulting in more CPV revenue for the Borough. Leslie will report back at the next meeting after attending the Borough Policy Session. Aaron will write up a list of local park needs and visitor use for Leslie, prior to her meeting with Rep. Ortiz. Amanda commented on contacting Sen. Steadman's office as well.
