### 150<sup>th</sup> anniversary of the Alaska Treaty of Cession

Peter Metcalfe is compiling *150 Reasons We Love Alaska* to promote the state as part of the commemoration of the 150<sup>th</sup> anniversary of the Alaska Treaty of Cession. All are invited to send a reason, explained in around 150 words about this place that is "both deeply familiar and wildly exotic." The plan is to have a publication with the list and possibly run reasons individually in a newspaper, or newspapers, starting in late March 2017. Submissions are needed by mid-February, and should be sent to [gov.alaska150@alaska.gov](mailto:gov.alaska150@alaska.gov).

### Walrus Islands Archeological District designated a National Historic Landmark

In January the National Park Service designated 24 new National Historic Landmarks. Alaska's Walrus Islands Archeological District, on Round Island in the Bering Sea, was one of them. The district has evidence of human occupation of the Bering Sea continental shelf when sea levels were substantially lower than at present. At least 6,000 years ago, people occupied the island, were marine-adapted, and hunted walrus on the beaches for subsistence. Round Island, with six other islands in northern Bristol Bay, is in a state game sanctuary. The landmark designation adds the district to the National Register of Historic Places as well.

### Alaska Highway and Dutch Harbor 75<sup>th</sup> anniversary commemorations being planned

The Public Information Office, Northern Region, Department of Transportation and Public Facilities has been hosting teleconferences to coordinate plans to commemorate the 75<sup>th</sup> anniversary of construction of the Alaska Highway. There are plans for activities at Delta Junction with the assistance of folks from Fort Greely on June 3 or 10, at Anchorage on July 1, and at Tok on July 4, 2017. The forthcoming edition of *The Milepost* will have a two-page special on the anniversary, Festival Fairbanks and Explore Fairbanks are getting banners for Airport Way in Fairbanks, a group is working on a project to have a monument in Anchorage, and the Anchorage School District plans to develop curriculum materials about the construction of the highway and the workers who built it.
