# 150<sup>th</sup> anniversary of the Alaska Treaty of Cession

In a number of Alaska communities and in Washington, D.C. the 150<sup>th</sup> anniversary of the signing of the Alaska Treaty of Cession was commemorated on March 30<sup>th</sup> with lectures, receptions, and music. The *150 Years: Kenai Peninsula History Conference* will be April 21-22 at the Kenai Peninsula College campus in Soldotna. There is something for everyone on the schedule, with presentations by area residents, archaeologists, historians, linguists, writers, poets, journalists, and preservation professionals. Dr. Andrei Znamenski will give the keynote address. Znamenski is author of *Shamanism and Christianity* and *Through Orthodox Eyes* investigating indigenous responses to 19<sup>th</sup> century Russian Orthodox missionaries in the Cook Inlet area. # Alaska Highway and Dutch Harbor 75<sup>th</sup> anniversary commemorations being planned

The Northern Region, Department of Transportation and Public Facilities has been hosting teleconferences to coordinate plans to commemorate the 75<sup>th</sup> anniversary of construction of the Alaska Highway. There are plans for activities at Delta Junction with the assistance of folks from Fort Greely on June 3 or 10, at Anchorage on July 1, and at Tok on July 4, 2017. There will be a memorial ceremony, history presentations, personal stories, a mess hall meal, traditional Unangax foods luncheon, and a
