#### Historic Preservation Fund FY 18 budget and tax reform legislation information

The President's and the House of Representatives budget proposals for Historic Preservation Fund programs for federal fiscal year 2018 (that started October 1, 2017) are summarized below. The Senate Appropriations Committee's budget proposal has been announced, but the full Senate has not passed its proposed budget. Congress passed a continuing resolution that is funding federal programs at FY 2017 levels through January 19, 2018.

The Senate Appropriations Committee included a new program, Historic Revitalization Grants, and the bill notes "the Committee has provided \$3,000,000 in new funding for preservation grants to revitalize historic properties of national, State and local significance in order to restore, protect and foster economic development of rural villages and downtown areas. Grants shall be made available to States, local governments, Tribes, or community non-profit organizations for the purpose of making sub-grants to eligible projects. Priority shall be given to applicants with a demonstrated capacity for allocating similar awards for preservation of such sites. The Committee recommends that applicants cap their administrative costs at no more than 5 percent."

The federal tax reform bill signed into law in late December kept the 20% Historic Tax Credit but changed how it can be claimed to taking it over five years instead of taking it all in one year. The bill did not include the 10% credit for rehabilitation of buildings constructed before 1936 that are not listed in the National Register of Historic Places that was formerly in place.

### Office of History and Archaeology and Alaska Historical Commission news

The office is resuming its Alaska Heritage Resources Survey (AHRS) training classes in 2018. The first two sessions are scheduled for January 24 and February 21, both from 10:00 a.m. to 12:00 noon. They will be held in the training room on the 9<sup>th</sup> floor of the Atwood Building, 550 West 7<sup>th</sup> Avenue in Anchorage. The class will include presentations on the Section 106 review and compliance process, the AHRS, and time for questions. The class is highly recommended for new users of the AHRS, especially for those who do not work with cultural resources on a regular basis. There is no cost for the training, but space is limited. The Alaska Historical Commission met by teleconference December 6, 2017. Commission members reviewed and approved the Gold Star Peak geographic name proposal for a peak near Mt. POW/MIA and the village of Eklutna. They determined the Jay and Bella Hammond Homestead eligible for listing in the National Register of Historic Places. Members reviewed applications from Certified Local Governments and recommended awards to the Matanuska-Susitna Borough for rehabilitation of the Rebarchek Farm, and to the City and Borough of Sitka for rehabilitation of Sheldon Jackson School's Fraser Hall and for predevelopment work on the former school's sawmill. Commission members also recommended that funding be offered to Certified Local Government staff and commission members for travel grants to attend the National Alliance of Preservation Commission (NAPC) Forum 2018 in Des Moines, Iowa next summer. ### Clam Cove Pictograph Site listed in National Register

The Keeper of the National Register of Historic Places added the Clam Cove Pictograph Site in Lake Clark National Park and Preserve to the nation's list of significant historic and archaeological properties on December 22, 2017. The site, on the western shore of Cook Inlet, has over 75 red ochre pictographs

associated with local Alutiiq culture and archaeological evidence of several houses and cache pits associated with the Dena'ina Athabascan people. The site contains data that could help to better understand the early lifeways of the Alutiiq and Dena'ina people. It has one of only two known rock art depictions of whale harpooning on the Pacific coast of the Alaska Peninsula before contact with Europeans.

# National Park Service updates

The National Park Service's Battlefield Protection Program is accepting grant applications for 2018. The program is for projects that lead directly to the identification, preservation, and interpretation of battlefields or historic sites associated with battlefields. The deadline to apply through Grants.gov is 11:00 a.m. Alaska time, January 18, 2018; and by regular mail postmarked by January 2, 2018. Program goals are to improve conservation, sustainability, and knowledge of the region's resources, preserve historic traditions and practices, interpret and communicate about the region's resources and values, and promote cultural connections and knowledge exchange.
