**Federal Historic Preservation Fund FY 18 budget increased by 21%**

The omnibus spending bill Congress passed and the President signed last month increases the Historic Preservation Fund apportionment from \$80.91 million in FY 17 to \$96.91 million in FY 18. This is a significant and welcome increase for preservation programs! President Trump’s FY 19 proposed budget for HPF programs, however, *only* supports the state and tribal preservation offices. It continues to be very important for Alaska’s historic preservation community to speak out and publicize projects and programs.

### Office of History and Archaeology and Alaska Historical Commission news

The Alaska Historical Commission will meet Wednesday, April 4, from 9:00 a.m. to 12:00 p.m. at the Atwood Building, 550 West 7<sup>th</sup> Ave., Suite 1270. The commission will address the Ch'u'itnu Historic District, Traditional Cultural Property (Tyonek vicinity) nomination to the National Register of Historic Places. They also will consider a geographic name proposal to change the name of Bulchitna Lake to Hneh'itnu Bena Lake (Matanuska-Susitna Borough) and one to name a feature Bergh Peak (Denali National Park). Commission members will get updates on historic preservation activities since their December 2017 meeting. ### National Park Service updates

The first in a series of special events to celebrate the centennial of Katmai National Park and Preserve will be April 28, 2018. Four speakers will talk about the geology and cultural history of Katmai, and the Anchorage Sugpiaq Dance Group will perform. The event will be at Cuddy Hall, University of Alaska Anchorage, from 10 a.m.-3 p.m. More information about Katmai's centennial events is at [www.katmaiconservancy.org](http://www.katmaiconservancy.org). The closing centennial event will be September 22, 2018 at Naknek. It will include presentations on the history and culture of fisheries in the Bristol Bay region.

The Tribal Heritage Historic Preservation grant application deadline is May 11, 2018. Federally recognized Indian tribes, Alaska Native groups and Native Hawaiian organizations are eligible to apply. Guidelines and application instructions are available at <http://go.nps.gov/znle88>.

The Vanishing Treasures Program of the National Park Service is presenting a workshop, *Guiding Principles for Field-Based Historic Preservation* in Anchorage, May 15-17, 2018. Topics include understanding how treatment decisions for historic resources are developed, how resources are evaluated, and how compliance, laws and the Secretary of the Interior's standards for historic preservation are connected to the work performed by trades personnel. The course, with classroom and field sessions, is geared to trades personnel, contractors, engineers, architects, and historic building

The National Fund for Sacred Places is seeking letters of intent for its grants for training, planning, and capital projects (from \$50,000 to \$250,000) that are open to congregations of all faiths for rehabilitation of their historic facilities. Letters of interest are due April 17, 2018. The fund is a program of Partners for Sacred Places in collaboration with the National Trust for Historic Preservation.
