## Office of History and Archaeology news

## **Alaska Historic Preservation Program grants**

Office of History and Archaeology announces it is now soliciting Historic Preservation grants, due January 22, 2024. Check our website for information on pre-development, development, and historic preservation program grants.

The Office of History & Archaeology (OHA) is accepting applications for historic preservation projects for 50-50 matching grant assistance for projects in Alaska. **This grant program also includes Development and Pre-development projects.** All projects would need to be completed by August 31, 2025.

Historic preservation grants provide 50 percent financial assistance with a 50 percent match for the cost of a project in one of the following categories:

- Survey
- Inventory
- National Register Nomination

- Historic Preservation Planning
- Public Preservation Education
- Predevelopment
- Development

The application deadline is 3:00 p.m. on Monday, January 22, 2024. The application package is available online at <a href="https://dnr.alaska.gov/parks/oha/designations/grants.htm">https://dnr.alaska.gov/parks/oha/designations/grants.htm</a>.

OHA estimates approximately \$300,000 will be available to award to eligible projects. The maximum federal share for any one project is \$50,000. The following lists the minimum and maximum amounts for each grant project:

- Development grant requests: \$10,000 minimum and \$50,000 maximum in grant/match share.
- Pre-development grant requests: \$3,500 minimum and \$15,000 maximum in grant/match share.
- All other grant requests have a minimum of \$3,500 and \$50,000 maximum in grant/match share.

## **CLG** grants

Alaska's fifteen Certified Local Governments received notification that there is a second round of CLG historic preservation grant program solicitation for grant proposals. The Office of History & Archaeology anticipates about \$100,000 will be available to award to eligible projects. The maximum federal share is \$50,000, with a 60/40 match. The application deadline is 3:00 pm on January 22, 2024.

#### **AHRSPortal**

OHA/SHPO has completed the database transition from the legacy AHRS-IBS to the AHRSPortal. User access to the AHRSPortal was not available for an automatic transfer. Alaska Heritage Resource Survey users who have not already done so will need to create accounts in the AHRSPortal. All AHRS Users, including state employees, need log-in with a myAlaska account (all non-state employees) or your state id and password (state employees only).

## mvAlaska Account

All non-state employees will access the AHRSPortal through myAlaska accounts. myAlaska is an independent state program that serves as a gateway to several online state services. The AHRSPortal will essentially be one of those services. You can review the various links and sign up for a myAlaska account at <a href="https://my.alaska.gov/">https://my.alaska.gov/</a>.

While creating a myAlaska account, please familiarize yourself with the myAlaska privacy policies, user agreements, and create/ identify a myAlaska account for use. New myAlaska accounts with your "business" email are recommended but not required. Note that signing up for a myAlaska account and creating an AHRSPortal account are two different steps. However, you must have a myAlaska account (for non-state employees) before creating an AHRSPortal account.

Determinations of Eligibility are regulations that provide guidance to Federal agencies in identifying and evaluating if a property located on lands under their jurisdiction or on lands to be affected by proposed actions is eligible for inclusion in the National Register. The National Register of Historic Places is the official list of the Nation's historic places worthy of preservation. So, what's the difference, and, more importantly, what's the point of getting a property determined eligible "listed" in the National Register?

### **Federal Legislation news**

The current Continuing Resolution takes a laddered approach to funding, where it funds some programs through **Jan. 19th** and others through **Feb. 2nd**. The Department of Interior, which

includes the Historic Preservation Fund (HPF) and other preservation priorities, would be funded through Feb. 2nd.

In November, the House passed their <u>FY24 Interior Appropriations bill</u>, which included funding for the HPF. The bill includes \$175.4 million for the HPF, a nearly \$30 million cut below current enacted levels. This includes level funding for SHPOs, THPOs and grant programs, but eliminates congressionally directed spending in the HPF.

HPF program authorization expired September 30, 2023. Congress can extend a program by continuing to appropriate funds as an "unauthorized appropriation." Efforts continue to support and promote legislation which would reinstate authorization and improve upon the former authorization – to include an increase in the authorized amount and number of years the authorization runs for. The bipartisan House bill H.R. 3350 remains in place. The provisions of that legislation call for an increase to \$250 million for 10 years. Currently, this bill does not have a Senate companion.

## **Department of the Interior news**

The Department of the Interior announced on December 6<sup>th</sup> a <u>final rule</u> to revise regulations that implement the Native American Graves Protection and Repatriation Act (NAGPRA). These regulations provide systematic processes for returning Native American human remains, funerary objects, sacred objects, or objects of cultural patrimony to lineal descendants, Indian Tribes, and Native Hawaiian Organizations (NHOs). The revised regulations streamline requirements for museums and federal agencies to inventory and identify Native American human remains and cultural items in their collections.

Enacted in 1990, NAGPRA, which is administered by the National Park Service, requires museums and federal agencies to identify Native American human remains, funerary items, and objects of cultural significance in their collections and collaborate with Indian tribes and Native Hawaiian organizations to repatriate them.

The final rule makes a number of changes, including:

- Strengthening the authority and role of Tribes and NHOs in the repatriation process by requiring deference to the Indigenous Knowledge of lineal descendants, Tribes and NHOs.
- Requiring museums and federal agencies to obtain free, prior and informed consent from lineal descendants, Tribes or NHOs before allowing any exhibition of, access to, or research on human remains or cultural items.
- Eliminating the category "culturally unidentifiable human remains" and resetting the requirements for cultural affiliation to better align the regulations with congressional intent.
- Increasing transparency and reporting of holdings or collections and shedding light on collections currently unreported under the existing regulation.
- Requiring museums and federal agencies to consult and update inventories of human remains and associated funerary objects within five years of this final rule.

The final rule will publish in the *Federal Register* in the coming days. Visit the <u>National NAGPRA website</u> for more information.

### **National Park Service news**

The NPS initiated consultation on the development of a Program Comment (one of the ACHP's allowed Section 106 program alternatives) for "Regular Maintenance, Capital Projects, and Leasing at Mission-66 Era (1945-1972) Facilities. A copy of the initiation letter is attached, and they have established a website for the effort at <a href="ParkPlanning-Mission-66 Program Comment (nps.gov">ParkPlanning - Mission-66 Program Comment (nps.gov)</a>. They have also prepared a "conceptual overview" which is attached.

They are inviting the public and SHPOs to two virtual consultation meetings on December 1st and December 8th. REGISTRATION IS REQUIRED and the details are in the attached consultation letter. They are seeking comments on the concept by January 8, 2023.

## **NPS** Grant opportunities:

The National Park Service is now accepting applications for the <u>Save America's Treasures</u> (SAT) grant program. The SAT program provides preservation and conservation assistance to nationally significant historic sites and collections. \$26.5 million will be competitively awarded. A dollar-for-dollar, non-Federal match, is required, this can be either cash or documented in-kind services. SAT is administered by the National Park Service (NPS) in partnership with the <u>National Endowment for the Arts</u> (NEA), the <u>National Endowment for the Humanities</u> (NEH), and the <u>Institute of Museum and Library Services</u> (IMLS). Preservation projects fund physical preservation of historic buildings, sites, structures, and objects. Collection projects include conservation of artifacts, museum collections, documents, sculptures, and works of art.

**Applications are due December 19, 2023.** To apply for funding for preservation projects go to opportunity number P23AS00499. To apply for funding for collections projects go to opportunity number is P23AS00500. With a background in archeology and cultural resource management, Rachel will oversee FPLAS activities within OFAP, working with federal agencies, states, Indian tribes, Native Hawaiian organizations and other stakeholders on individual Section 106 reviews and program and policy development relating to federal assistance agencies and historic preservation.

Nominations for 2024 ACHP/HUD Secretary's Award for Excellence in Historic Preservation now being accepted. Submissions due by 11:59 p.m. PST on December 18, 2023.
