### Federal funding and legislation for historic preservation programs

The authorization of the federal Historic Preservation Fund that supports state and tribal historic preservation programs and funds special initiatives has been expired for more than a year. A number of bills have been before Congress that include a reauthorization provision, and the administration's FY17 budget proposal included a provision for permanent authorization. In the last days of this Congress, there are three potential paths for reauthorization: as part of Senate energy bill S.2012, part of a National Park Service centennial bill, or passing the stand-alone bill H.R. 2817. Preservation groups report there are big problems with the energy and centennial bills, so are working to get H.R. 2817 passed. "This is challenging, but possible" according to Ted Monoson, National Conference of State Historic Preservation Officers.

Despite the fact the HPF is not authorized, it will receive funding in FY 17. The Administration, House of Representatives, and Senate proposals for HPF funding for FY 17 (October 1, 2016-September 30, 2017) are given in the table below. Senators Lisa Murkowski and Bill Cassidy led the effort to raise funding for the state programs, the first increase in five years, and the House budget committee accepted the

increase. Congress passed a continuing resolution to fund the government programs at FY 16 levels through December 9<sup>th</sup>.

### 150<sup>th</sup> anniversary of the Alaska Treaty of Cession activities

Governor Walker issued a proclamation October 17<sup>th</sup> declaring 2017 *The Alaska Year of History and Heritage*. It encourages "all Alaskans to take the occasion of this 150<sup>th</sup> anniversary [of the Alaska Treaty of Cession] year to study, teach, reflect upon our past, and apply its lessons to a brighter, more inclusive future."
