SPECIAL PARK USE PERMIT STIPULATIONS - UPPER TIKCHIK LAKES/TIKCHIK RIVER

1. **NON-ASSIGNMENT-** This permit may not be assigned without the written approval and acceptance of the assignee by the director or his/her designee. Further, the permittee shall not sublet or enter into any third-party agreements involving the privileges authorized by this permit.
2. **NON-WAIVER PROVISION-** The failure to enforce provision of this permit or any default on the part of the permittee in observance or performance of any of the conditions or requirements of this permit is not a waiver of the forfeiture provision or any other provision of the permit.
3. **STRUCTURES-** Structures are prohibited from being placed by the permittee on state park lands or waters.
4. **FORFEITURE-** Permittee shall forfeit the permit if he/she defaults in the performance or observance of any of the permit terms, covenants or stipulations or of a statute/regulation.
5. **STATE HELD HARMLESS-** The permittee agrees to indemnify, defend and hold harmless the State of Alaska from any and all liability claims arising from the actions of the permittee or his/her agents, employees or clients while conducting activities under this permit on state park lands/waters.
6. **VALID CLAIMS AND APPLICABLE LAWS-** This permit is subject to all valid claims and applicable laws and regulations.
7. **PROTECTION OF PARK LAND AND PROPERTY FROM DAMAGE-** Permittee shall exercise diligence in protecting from damage the land, property and resources of the State of Alaska in the area covered by and used in connection with this permit and shall pay the state for any damage resulting from negligence or from the violation of the terms of this permit or any law or regulation applicable to the use of state parks by the permittee.
8. **GEOGRAPHIC LIMIT-** This permit is applicable only for the use areas described.
9. **NO PREFERENTIAL RIGHT OF RENEWAL-** No preferential rights or rights of renewal or are attached to this permit.
10. **NATURAL HAZARDS-** The permittee recognizes and understands that natural hazards are likely to exist within the area of his/her operation and agrees to take all reasonable precautions to make him/her aware of these hazards and to avoid injury to persons or property.
11. **STATE INSPECTION-** The state reserves the right to inspect areas of activity under this permit.
12. **FIREARMS-** Target shooting is prohibited within the park. The use and discharge of a weapon for the purpose of lawful hunting or trapping is allowed. Firearms will be the direct responsibility of the permittee. Misuse of firearms in violation of state or federal laws or regulations, may result in termination of this permit.
13. **CAMP CLEANLINESS-** The permittee agrees to take adequate precautions around camp to prevent human/bear encounters. Camps must be kept clean and food cached away from any camp.
14. **LITTER-** Permittee shall remove all litter caused by their activities and shall make a reasonable effort to pick up and remove all litter found in the park. No trash or garbage may be burned.
15. **CAMPFIRES-** Campfires are allowed only on gravel bars and beaches. Adequate precautions must be taken to minimize risk of wildfire, including not leaving fires unattended and extinguishing fires and coals completely with water. Fire rings shall be disassembled and wet ashes scattered prior to departure.
16. **GROUP SIZE-** Group size is not to exceed 10 persons.
17. **FIREWOOD-** Cutting live vegetation is prohibited. Gathering firewood is limited to dead and down wood.
18. **GENERATORS-** Use of generators is prohibited.
19. **SANITATION-** The permittee agrees to dispose of human waste at least 200 feet from surface water. Toilet paper will be packed out or burned and waste covered with topsoil or contained and removed to an approved disposal facility. Dumping of human waste in park waters is prohibited
20. **CHIKUMINUK LAKE-** The use of a motorized boat is prohibited on Chikuminuk Lake.
21. **STAY LIMITS-** A person may not camp at the same location in an undeveloped area of a state park for more than 10 consecutive days. After 10 consecutive days at the same location all camping equipment must be removed and may not be set up or used again within one mile of that location during the next 10 days.
22. **'LEAVE NO TRACE'-** The land and water covered under this permit is managed as wilderness. Permittees agree to leave the area in its natural state with little or no evidence of use.

I agree to abide by the terms and conditions of this permit, including the attached stipulations, will have a copy of permit in possession when conducting activities authorized by this permit and will confine activities to those described herein. I understand that non-compliance with stipulations may result in a citation being issued and permit suspension or revocation.
