I. Name of Mineral Order: Forest Knolls Subdivision – ADL 232332

II. Reason for Mineral Order: This Mineral Order is based upon the attached *Finding of the Commissioner* and the written justification contained in the following:
Kenai Area Plan, adopted (2000, up-dated 2001)
Preliminary Decision, Forest Knolls Subdivision – ADL 232332, August 31, 2017 and the subsequent Final Finding and Decision for same
Land Sale pursuant to AS 38.05.035(e)

III. Authority: AS 38.05.185 and AS 38.05.300.

IV. Location and Legal Description: Project is on Old Sterling Highway approximately 5.5 air miles south of Anchor Point within Seward Meridian, Township 5 South, Range 14 West, Section 30:

- NE $\frac{1}{4}$ NE $\frac{1}{4}$ SE $\frac{1}{4}$ NW $\frac{1}{4}$ north of Old Sterling Highway
- NE $\frac{1}{4}$ excluding:
 - E $\frac{1}{2}$ W $\frac{1}{2}$ NW $\frac{1}{4}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$;
 - W $\frac{1}{2}$ E $\frac{1}{2}$ NW $\frac{1}{4}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$;
 - SE $\frac{1}{4}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$; and
 - SW $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$;
