

PUBLIC NOTICE – FORT KNOX MINE FEDERAL PERMIT APPLICATION AND DRAFT STATE DECISIONS

The U.S. Army Corps of Engineers (ACOE) and the State of Alaska are releasing on June 29, 2006 the application, draft permits, public notice and decisions, below, relating to the Fort Knox Mine for a 30-day public review and comment period. The project applicant, Fairbanks Gold Mining, Inc. (FGMI), is a wholly owned subsidiary of Kinross Gold Corporation. The Fort Knox open-pit gold mine is located approximately 26 miles northeast of Fairbanks, Alaska. The operator is proposing to add a heap leach gold recovery facility in the Walter Creek drainage and is requesting modification of various existing permits and authorizations.

- ACOE is publishing the public notice for an application for a Department of the Army permit pursuant to Section 404 of the Clean Water Act.
- The Alaska Department of Natural Resources (ADNR) has prepared a Draft Plan of Operations Amendment Approval (including a Draft Reclamation Plan Approval) and a Draft Addendum to the Millsite Lease.
- The Alaska Department of Environmental Conservation (ADEC) has prepared a Draft Waste Management Permit (2006-DB0043) for disposal of tailings, mined material to be placed on a heap leach facility, and inert solid wastes at the Fort Knox Mine. ADEC also anticipates that it will issue a certification of the 404 permit to be prepared by ACOE authorizing the placement of fill in wetlands.
