Pursuant to AS 16.05.841, the Alaska Department of Fish and Game (ADF&G) Division of Habitat reviewed your proposed modifications for two bridges located on tributaries to Sherman Creek that support the Kensington Gold Mine. These structures are located upstream of the cataloged anadromous portion of Sherman Creek (Stream No. 115-31-10330).


### Project Description

You will replace the South Fork Sherman Creek and Upper Sherman Creek log stringer bridges with new full-span premanufactured steel bridges in the same location. You will leave the original timber cribbing below the ordinary high water marks to maintain bank stabilization.

In accordance with AS 16.05.841, permits FH11-I-0134 and FH11-I-0135 are hereby amended. All other terms and conditions from the original permit remain in place.
