Proposed Project and Location:

The Kensington gold project is located 45 miles north of Juneau Alaska. The mine operates two wastewater treatment facilities, one located at the tailings treatment facility, and one located

above Sherman Creek.

The tailing treatment facility water treatment plant will receive water from slurry transport of settled tailings, as well as undiverted natural inflows from drainage areas immediately adjacent to the tailings treatment facility, and infrequent overflows from the Upper Slate Lake diversion structure. The treated wastewater is discharged through outfall 002 into the Upper Slate Lake diversion pipe. The diversion pipe conducts the combined water to the head of East Fork Slate Creek.

Mine drainage is treated at the mine water treatment plant and discharged to Sherman Creek through outfall 001.
