**RE:** Kensington Mine Comet Footpath Reclamation Estimate

Dear Mr. Groom,

As mentioned in previous conversations, Coeur Alaska plans to construct a gravel footpath from the Comet Water Treatment Plant to the Sherman Creek outfall. A gravel footpath adjacent to the current wooden walkway is needed for safe access to repair the walkway, interim access to Sherman Creek and to provide access for maintenance of the outfall piping. The proposed pathway would be approximately 10 feet wide and 430 feet long. Please see the attached map with the location of the footpath. The footpath would be constructed using 12-inch minus development waste rock as a base and a top layer of crushed 1-inch minus waste rock. Please note approximately half the length of the footpath falls into the already approved POA-1 disturbance boundary, see attached map.

At mine closure the footpath would be capped with topsoil and seeded with a native seed mix according to the Kensington Mine Reclamation and Closure Plan. The footpath reclamation will be incorporated into the next reclamation plan update which occurs in April 2028. The estimated reclamation costs with contingencies and inflation are \$22,573, please see attached table for the detailed costs. These costs will be added to the reclamation bond at the next bond update.

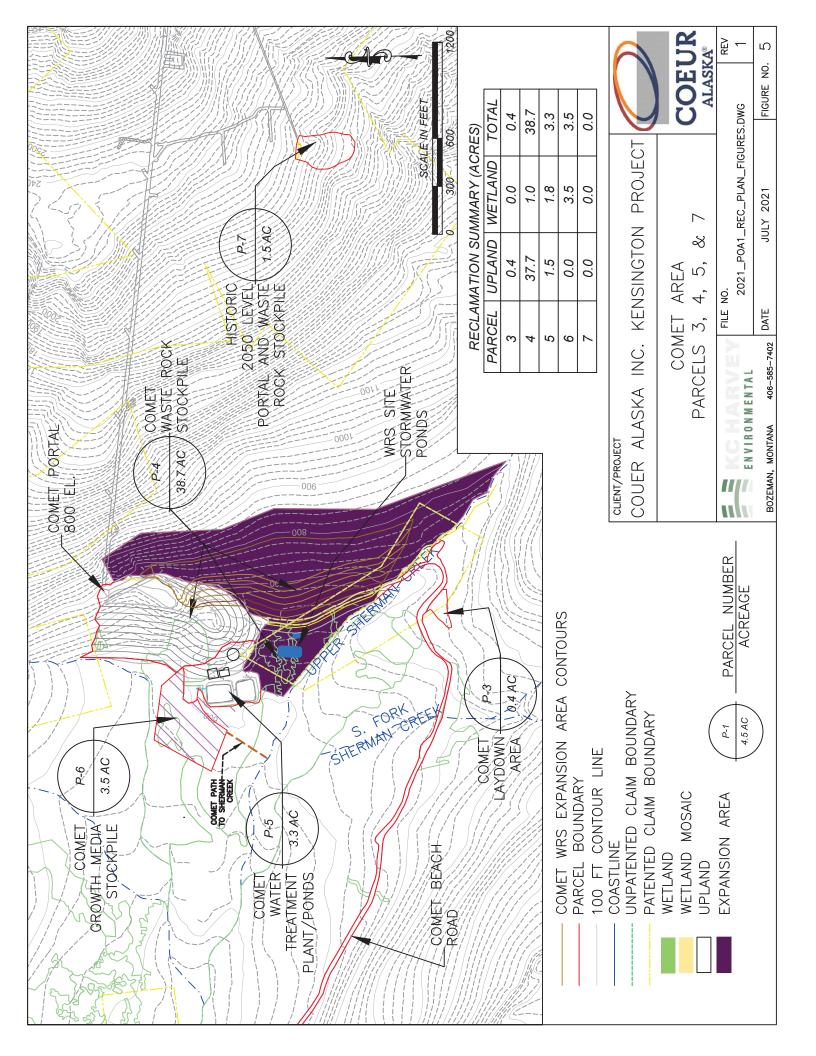
