The Office of Project Management and Permitting (OPMP) has received the Coastal Project Questionnaire (CPQ) and consistency certification, applications, and supporting information you submitted for Niblack Mining Corporation's (NMC) proposed mine exploration phase within the bay known as Niblack Anchorage on southeast Prince of Wales Island near Moira Sound, in Southeast Alaska. OPMP is coordinating a review for consistency with the Alaska Coastal Management Program (ACMP) (AS 46.40). This letter initiates the State of Alaska review of this proposed project under the schedule and process described in State regulations (11 AAC 110) and includes a summary of the scope of the project and the review process.

DESCRIPTION OF PROJECT SUBJECT TO REVIEW:

The "Niblack Project" is a copper-gold-silver prospect in an advanced exploration phase of development. The proposed underground exploration project is located off Moira Sound in Niblack Anchorage on southeastern Prince of Wales Island, approximately 30 air miles from the community of Ketchikan, Alaska.

The applicant, Niblack Mining Corporation, proposes to develop 6,000 feet of underground tunneling from a single adit entry. The main focus of the underground work is to provide access for exploration drilling to test deep zones of mineralization. The project is expected to last 2 years. It will require a marine access and camp barge facility on the adjacent state-owned tide and submerged lands. Other surface disturbances including an access road, portal, and waste rock storage and disposal areas will be confined to private property.

Total surface disturbance requiring post-closure reclamation is approximately 5.5 acres. The proposed underground excavation will generate about 60,900 cubic yards of waste rock, most of

which is benign. Approximately 14,300 cubic yards is potentially acid-generating (PAG) material which will be placed in an engineered, lined 0.85-acre storage facility. At the end of the exploration period, all PAG waste rock will be picked up and transferred back underground and the adit will be sealed.

Background Information -

In 1996 Abacus Minerals Corporation proposed an uplands crew camp site for support of their continued exploratory work at the mine site. This camp site was reviewed for consistency with the ACMP in 1996 under "AK 9604-06J". NMC has recently acquired the Niblack Anchorage assets of Abacus Minerals Corporation.

Additional Review Information -

The Department of Natural Resources (ADNR) has developed the Large Mine Project Team LMPT) approach to reviewing larger mining projects that may require multiple Federal and State authorizations to cover proposed activities within the State of Alaska. The Niblack Mine in Southeast Alaska has been handled by the various State agencies in this LMPT-coordinated scenario. For projects that are sited within the coastal zone of Alaska and require an ACMP consistency review for Federal or State authorizations, the ADNR's Office of Project Management and Permitting's (OPMP) LMPT Project Manager (in this case Mr. Bob Tsigonis) is the coordinator of <u>all</u> facets of mine project permit review – including the ACMP consistency review. SCOPE OF PROJECT TO BE REVIEWED:

The scope of the project subject to the consistency review includes all Federal and selected State applications and supporting documents submitted to gain authorizations for this proposed underground exploratory phase of the development of the Niblack Mine and support facilities on the uplands and tide and submerged lands within Niblack Anchorage in Southeast Alaska.

The water quality authorizations from the Alaska Department of Environmental Conservation (ADEC) will not be within the scope of this coordinated ACMP consistency review, but rather will be the subject of a review process coordinated directly by ADEC. Interested parties are hereby notified that a Department of the Army permit application has been received for work in waters of the United States as described below and shown on the enclosed project drawings.

APPLICANT: Niblack Mining Corporation, 615-800 West Pender Street, Vancouver, BC, V6C 2V6

AGENT: Mr. Rick Richins, RTR Resource Management, 1109 West Main Street, Suite 480, Boise, Idaho 83702; phone (208) 343-8727.

LOCATION: The proposed project site is located within Section 34, T. 78 S., R. 88 E., Copper River Meridian; Latitude 55.0667° N., Longitude 132.1461° W.; in Niblack Anchorage, off of Moira Sound on Prince of Wales Island.

PURPOSE: The applicant's stated purpose is for safe personnel and equipment access. The proposed marine barge landing facility and dock is also needed to ensure safe and reliable off-loading of industrial equipment required to develop the underground workings which are needed for the mineral exploration activities by Niblack Mining Corporation on the adjoining Niblack property.

PROPOSED WORK: The following work is proposed:

- Construct a 24-foot wide by 60-foot long barge and landing craft ramp.
 Approximately 500 cubic yards of fill would be placed below the high tide line for the ramp;
- Construct a 10-foot by 100-foot pile supported walkway;
- Construct a 5-foot by 70-foot float ramp;
- Construct a 10-foot by 225-foot pile-supported steel and wood float; and
- Moor a 50-foot by 150-foot camp barge.
- Install twelve 16-inch steel piles to support the structures.
- Install a one-inch water line to supply the camp barge with water for domestic use. The water line would be attached to the walkway and floats.

ADDITIONAL INFORMATION: A permit modification for temporary facilities adjacent to this site was authorized under POA-1982-290-M, on April 16, 2007. The applicant anticipates using the temporary site until they are able to obtain permanent authorizations.

The applicant has supplied an updated reclamation plan and bond calculation for the Niblack Project to the Alaska Division of Mining, Land and Water. An authorization from the Alaska Department of Natural Resources, Division of Mining, Land and Water, must be issued for the exploration project. For information on the State program you may contact Mr. Bob Tsigonis at 907-374-3708. Copies of the complete State permit application can be found at Alaska Division of Mining, Land and Water in Fairbanks and in Anchorage. In addition, the State web page has the application information and is available for viewing at: www.dnr.state.ak.us/mlw/mining/largemine/niblack. MITIGATION: Pile-supported structures are being proposed to the maximum extent possible. In addition, the mining camp is being proposed as a float camp, reducing impacts to wetlands and other waters of the U.S.

WATER QUALITY CERTIFICATION: A permit for the described work will not be issued until a certification or waiver of certification, as required under Section 401 of the Clean Water Act (Public Law 95-217), has been received from the Alaska Department of Environmental Conservation.

COASTAL ZONE MANAGEMENT ACT CERTIFICATION: Section 307(c)(3) of the Coastal Zone, Management Act of 1972, as amended by 16 U.S.C. 1456(c)(3), requires the applicant to certify the described activity affecting land or water uses in the Coastal Zone complies with the Alaska Coastal Management Program. A permit will not be issued until the Office of Project Management and Permitting, Department of Natural Resources has concurred with the applicant's certification.

CULTURAL RESOURCES: The latest published version of the Alaska Heritage Resources Survey (AHRS) has been consulted for the presence or absence of historic properties, including those listed in or eligible for inclusion in the National Register of Historic Places. There are no listed or eligible properties in the vicinity of the worksite. Consultation of the AHRS constitutes the extent of cultural resource investigations by the District Commander at this time, and he is otherwise unaware of the presence of such resources. This application is being coordinated with the State Historic Preservation Office (SHPO). Any comments SHPO may have concerning presently unknown archeological or historic data that may be lost or destroyed by work under the requested permit will be considered in our final assessment of the described work.

ENDANGERED SPECIES: No threatened or endangered species are known to use the project area. Preliminarily, the described activity will not affect threatened or endangered species, or modify their designated critical habitat, under the Endangered Species Act of 1973 (87 Stat. 844). This application is being coordinated with the U.S. Fish and Wildlife Service and the National Marine Fisheries Service (NMFS). Any comments they may have concerning endangered or threatened wildlife or plants or their critical habitat will be considered in our final assessment of the described work.

ESSENTIAL FISH HABITAT: The Magnuson-Stevens Fishery Conservation and Management Act, as amended by the Sustainable Fisheries Act of 1996, requires all Federal agencies to consult with the NMFS on all actions, or proposed actions, permitted, funded, or undertaken by the agency, that may adversely affect Essential Fish Habitat (EFH). Preliminarily, the described activity may affect EFH in the project area. This Public Notice initiates EFH consultation with the NMFS. Any comments or recommendations they may have concerning EFH will be considered in our final assessment of the described work.



TRIBAL CONSULTATION: The Alaska District fully supports tribal self-governance and government-to-government relations between Federally recognized Tribes and the Federal government. Tribes with protected rights or resources that could be significantly affected by a proposed Federal action (e.g., a permit decision) have the right to consult with the Alaska District on a government-to-government basis. Views of each Tribe regarding protected rights and resources will be accorded due consideration in this process. This Public Notice serves as notification to the Tribes within the area potentially affected by the proposed work and invites their participation in the Federal decision-making process regarding the protected Tribal right or resource. Consultation may be initiated by the affected Tribe upon written request to the District Commander during the public comment period.

PUBLIC HEARING: Any person may request, in writing, within the comment period specified in this notice, that a public hearing be held to consider this application. Requests for public hearings shall state, with particularity, reasons for holding a public hearing.

EVALUATION: The decision whether to issue a permit will be based on an evaluation of the probable impacts including cumulative impacts of the proposed activity and its intended use on the public interest. Evaluation of the probable impacts, which the proposed activity may have on the public interest, requires a careful weighing of all the factors that become relevant in each particular case. The benefits, which reasonably may be expected to accrue from the proposal, must be balanced against its reasonably foreseeable detriments. The outcome of the general balancing process would determine whether to authorize a proposal, and if so, the conditions under which it will be allowed to occur. The decision should reflect the national concern for both protection and utilization of important resources. All factors, which may be relevant to the proposal, must be considered including the cumulative effects thereof. Among those are conservation, economics, aesthetics, general environmental concerns, wetlands, cultural values, fish and wildlife values, flood hazards, floodplain values, land use, navigation, shore erosion and accretion, recreation, water supply and conservation, water quality, energy needs, safety, food and fiber production, mineral needs, considerations of property ownership, and, in general, the needs and welfare of the people. For activities involving 404 discharges, a permit will be denied if the discharge that would be authorized by such permit would not comply with the Environmental Protection Agency's 404(b)(1) guidelines. Subject to the preceding sentence and any other applicable guidelines or criteria (see Sections 320.2 and 320.3), a permit will be granted unless the District Commander determines that it would be contrary to the public interest.

The Corps of Engineers is soliciting comments from the public; Federal, State, and local agencies and officials; Indian Tribes; and other interested parties in order to consider and evaluate the impacts of this proposed activity. Any comments received will be considered by the Corps of Engineers to determine whether to issue, modify, condition or deny a permit for this proposal. To make this decision, comments are used to assess impacts on endangered species, historic properties, water quality, general environmental effects, and the other public interest factors listed above. Comments are used in the preparation of an Environmental Assessment and/or an Environmental Impact Statement pursuant to the National Environmental Policy Act. Comments are also used to determine the need for a public hearing and to determine the overall public interest of the proposed activity.

Comments on the described work, with the reference number, should reach this office no later than the expiration date of this Public Notice to become part of the record and be considered in the decision. 






Marine Facility Diagram Detailed Plan


Location T78S R88E Meridian: Copper River

Project Description:

The "Niblack Project" is a copper-gold-silver prospect in an advanced exploration phase of development. The proposed underground exploration project is located off Moira Sound in Niblack Anchorage on southeastern Prince of Wales Island, approximately 30 air miles from the community of Ketchikan, Alaska.

The applicant, Niblack Mining Corporation, proposes to develop 6,000 feet of underground tunneling from a single adit entry. The main focus of the underground work is to provide access for exploration drilling to test deep zones of mineralization. The project is expected to last 2 years. It will require a marine access and camp barge facility on the adjacent state-owned tide and submerged lands. Other surface disturbances including an access road, portal, and waste rock storage and disposal areas will be confined to private property.

Total surface disturbance requiring post-closure reclamation is approximately 5.5 acres. The proposed underground excavation will generate about 60,900 cubic yards of waste rock, most of which is benign. Approximately 14,300 cubic yards is potentially acid-generating (PAG) material which will be placed in an engineered, lined 0.85-acre storage facility. At the end of the exploration period, all PAG waste rock will be picked up and transferred back underground and the adit will be sealed.

Additional Review Information -

The Department of Natural Resources (ADNR) has developed the Large Mine Project Team LMPT) approach to reviewing larger mining projects that may require multiple Federal and State authorizations to cover proposed activities within the State of Alaska. The Niblack Mine in Southeast Alaska has been handled by the various State agencies in this LMPT-coordinated scenario. For projects that are
