**PLAN OF OPERATIONS MINOR MODIFICATION POGO STP DISCHARGE LINE**

Northern Star (Pogo) LLC requests a minor modification to the Plan of Operations (F20189500 - approved on May 24, 2018 and amended on November 6, 2018 and January 7, 2019) to include the Sewage Treatment Plant (STP) discharge line and Outfall002. The line is shown on the attached **Figure 1: STP Discharge Line Location**.

Following consultation with ADNR staff, Pogo requests approval to include the STP discharge line and Outfall002 in the Pogo Mine Plan of Operations (POO) instead of renewing the Right-of-Way Permit, ADL 417113. The legal description of the current easement in the recorded document states the location to be in the SE ¼ Section 34, Township 5 South, Range 14 East, Fairbanks Meridian, Fairbanks Recording District. To be consistent with the latitude and longitude recorded, Pogo would also like to update the legal description to say NE ¼ Section 34. STP line and outfall are situated within the Pogo Mine Millsite Lease Boundary, ADL 416949. No changes will be made to the STP discharge line or Outfall002.

All actions will be conducted in accordance with the Pogo Mine permits, including the APDES (AK0053341), Air Quality (AQ0406MSS07 and AQ0406TVP02), MSGP (AKR060000), and WMP (2018DB0001).
