**Subject: Extension of the Pogo Mine Plan of Operations Approval (F20129500)**

Dear Mrs. DePalma:

On December 5, 2016 the Department of Natural Resources received a letter (copy enclosed) from Sumitomo Metal Mining Pogo, LLC (Pogo) requesting an extension for submission of an updated application package to renew your Pogo Mine Plan of Operations Approval (F20129500) (POOA). Your letter indicated that the mine reclamation and Right-of-Way (ROW) reclamation cost estimates and updated Reclamation and Closure Plan would be submitted no later than February 15, 2017. The Division of Mining Land & Water approved this request and extended the POOA that was due to expire on February 6, 2017, to June 1, 2017.

The updated application package was submitted on February 15, 2017. The agencies have not completed review of the updates to the Plan of Operations and reclamation cost estimates. In order to allow time to complete the agency review and to accommodate a coordinated public notice process, the Department of Natural Resources, Division of Mining, Land & Water (DMLW) administratively extends POOA (F20129500) until December 1, 2017.

A person affected by this decision may appeal it, in accordance with 11 AAC 02. Any appeal must be received within 20 calendar days after the date of issuance of this decision, as defined in 11 AAC .2.040(c) and (d), and may be mailed or delivered to the Commissioner, Department of Natural Resources, 550 W. 7<sup>th</sup> Avenue, Suite 1400, Anchorage, Alaska, 99501, faxed to 907-269-8918, or sent by electronic mail to [dnr.appeals@alaska.gov](mailto:dnr.appeals@alaska.gov). This decision takes effect immediately. If no appeal is filed by the appeal deadline, this decision becomes a final administrative order and decision of the department on the 31<sup>st</sup> day after issuance. An eligible person must first appeal this decision in accordance with 11 AAC 02 before appealing this decision to superior court. A copy of 11 AAC 02 may be obtained from any regional information office of the Department of Natural Resources.

Plan of Operations - Application for Renewal**

Dear Kyle:

I am writing to follow-up on the November 8, 2016 meeting regarding the renewal of Sumitomo Metal Mining Pogo, LLC's (Pogo) Plan of Operations and to request a short extension of time to submit updated mine reclamation and ROW reclamation cost estimates and an updated Reclamation and Closure Plan in support of the renewal application.

Under Pogo's Plan of Operations Approval (F20129500), Pogo's application for renewal must be submitted no later than January 6, 2017 (30 days before the expiration date of the Plan of Operations Approval).

Pogo has engaged SRK Consulting (U.S.), Inc. (SRK) to update the mine reclamation and ROW reclamation cost estimates using the Standard Reclamation Cost Estimator (SRCE) Model. SRK is also updating Pogo's Reclamation and Closure Plan.

The SRCE Model was not previously used to develop the mine reclamation and ROW reclamation cost estimates in the current Plan of Operations Approval. SRK has indicated that additional time is needed to convert the mine reclamation and ROW reclamation cost estimates to the SRCE Model and update the Reclamation and Closure Plan. SRK anticipates that it will have the updated mine reclamation and ROW reclamation cost estimates and the updated Reclamation and Closure Plan completed no later than February 7, 2017.

No later than January 6, 2017, Pogo will submit its application for renewal without the cost estimates and the updated Reclamation and Closure Plan. Pogo requests an extension to February 15, 2017 to submit the updated cost estimates and the updated Reclamation and Closure Plan. We believe this request is reasonable and is not made for any purpose of delay.

Pogo understands that until the Department of Natural Resources issues a new approval, the existing Plan of Operations Approval continues to remain in effect.

We appreciate the Department of Natural Resources' consideration of this request.
