- Allow representatives of the Department to inspect the work and records covered by this certificate at all times determined necessary by the Commissioner.
- Follow special conditions listed in Attachment A, attached hereto and made a part hereof.

### Attachment A – Special Conditions

- This certificate approves constructing RTP head tank #2 as described in the Application for Certificate of Approval to Modify a Dam received on November 12, 2014 including "General Structural Notes, Pogo Mine, RTP Head Tank #2 Foundation, Delta Junction, Alaska" dated October 7, 2014 and "RTP Head Tank #2 Review and Observations" dated September 30, 2014 from Shannon & Wilson, Inc.
- During the modification and after construction is complete, the Pogo R.T.P. Dam must be operated as a Class I (high) hazard potential classification dam as defined in 11 AAC 93.157.
- 3. No less than 14 days prior to beginning construction, submit a construction schedule to the Department. Submit a revised construction schedule for any substantial deviations from the schedule previously submitted to the Department.
- 4. The foundation of the water tank, including the subgrade and any compacted fill, shall be inspected by a qualified geotechnical engineer to verify the bearing capacity, soil types encountered and compaction specifications. Provide a foundation report describing the findings of the inspection within 14 days of the completion of foundation construction.
- 5. If any conditions are encountered which require substantial clarification, deviation or change in the design from the approved drawings and specifications, the clarification, deviation or change must be approved in writing by the design engineer and submitted to the Department. Any clarification, deviation or change that could affect the safety of the dam must be approved in writing by the Department before continuing that aspect of construction.
- 6. Notify the Department within one week after the date of substantial completion of the approved modification.
- 7. Submit the following post-construction documentation within 30 days of substantial completion of the approved modification:
  - □ A site plan showing the as-built location of the modification with respect to the abutment of the dam and other features in the vicinity.
- 8. Commence construction by the October 1, 2016. If construction does not begin by this date, an updated application must be submitted for review and approval by the Department, including application fees required under 11 AAC 05.010.
