  - a. DNR State Parks Park Staff

Chief Ranger Tom Anthony provided a report of guide violations for the field season, along with enforcement trends from the past season, retaining snagged fish and habitat closures are both top enforcement actions. Chief Ranger Anthony also introduced the ADF&G and Parks Habitat closure signs, and concerns from river users on difficulty of interpretations. Parks will be seeking Board input on "green sign" updates prior to summer 2025. Superintendent Rinke Briefed the Board on facility improvement updates at Eagle Rock, Big Eddy, and Morgan's Landing, in addition to updating the Board on EVOS property acquisitions near the Lower Killey and Bear Creek.

USFS Ruth D'Amico Ranger DiAmico state the Russian River was less hectic then in 2023, the access road is under construction for the season and should be completed in the fall of 2025 with paving occurring as soon as April of 2025. Additionally, the USFS has been burning piles created by spruce bark beetle mitigation activities in Moose Pass, and air curtain burner was purchased and put to use in an effort to expedite this effort.

Tyler reported the City had a busy year during the dip net season, the north beach is gaining in popularity, the Dip Net end of year report is being finalized and should be out by mid December. The City is looking to add a Kids Don't Float Life Vest station.
