Historic Preservation Fund Certified Local Government Grants Catalogue 1987-2024

Alaska has fourteen (14) local governments certified as historic preservation partners with state and federal programs. The state's historic preservation program is led by the Alaska Office of History and Archaeology. The state annually receives a grant from the federal Historic Preservation Fund to carry out the programs identified in the 1966 National Historic Preservation Act. Ten percent of Alaska's award is for Certified Local Government projects. The local governments apply for funds that must relate to preservation priorities established by the Alaska Historical Commission, the state board that reviews the proposals.
