#### Federal Legislation

Coronavirus Aid, Relief, and Economic Security Act (CARES Act), This \$2 trillion economic stimulus bill is the third in a series of emergency relief bills in response to COVID 19. Some sections of the bill of interest to the preservation community:

The portion of the bill that provides \$275 million for the General Services Administration's Federal Building Fund includes language that says:

No action taken by the Administrator to acquire real property and interests in real property or to improve real property in response to coronavirus shall be deemed a Federal action or undertaking and subject to review under the National Environmental Policy Act of 1969 or the National Historic Preservation Act of 1966.

The bill includes \$75 million for the National Endowment for the Arts and \$75 million for the National Endowment for the Humanities, which can pass on the money to institutions that need it. Another \$50 million was designated to the Institute of Museum and Library Services, which distributes funds to museums and libraries. The CARES Act does not include any direct funding for historic preservation.

Approximately 40 percent of the appropriation, or \$30 million, will go directly to the 56 state and jurisdictional humanities councils, based on the standard population formula used for their annual appropriation. The remaining 60 percent, or \$45 million, will support at-risk humanities positions and projects at museums, libraries and archives, historic sites, colleges and universities, and other cultural nonprofits that have been financially impacted by the coronavirus. All NEH supplemental funds must be obligated to projects by September 30, 2021.

# Historic Preservation Advocacy Week, March 9-12, 2020

Historic preservationists from across the country met in Washington D.C, in March for Historic Preservation Advocacy Week. They requested from Congress full funding at \$150 million for the Historic Preservation Fund, including increases for State and Tribal Historic Preservation Officers and key historic preservation grant programs like the Paul Bruhn Historic Revitalization grant program, Civil Right Movement grants and the Save America's Treasures program. They requested:

- State Historic Preservation Offices: **\$61 million**
- Tribal Historic Preservation Offices: **\$22 million**
- African-American Civil Rights Movement Grants: **\$20 million**
- Civil Rights Grants for All Americans: \$8 million
- Historically Black Colleges and Universities: **\$10 million**
- Survey Grants for Underrepresented Communities: \$1 million
- Save America's Treasures Grants: \$18 million
- Paul Bruhn Historic Revitalization Grants: **\$10 million**

The Alaska SHPO has invoked tolling effective March 19, 2020 regarding the timelines outlined in 36 CFR 800. With tolling, the 30-day regulatory clock that would allow agencies to proceed with their undertaking following non-response after 30 days does <u>not</u> apply. SHPO will be allowed to comment beyond the 30 days.

The Office of History and Archaeology's annual workshop scheduled for April 21, 2020 has been postponed to a possible fall date.

#### Alaska Historical Commission

The next meeting of the Alaska Historical Commission will be by teleconference on Monday, April 27, 2020. The agenda includes review of applications for grant projects from Certified Local Governments and for development/predevelopment historic preservation grant projects. ## National Park Service

The Technical Preservation Services office, which administers the Federal Historic Preservation Tax program is open but the staff are currently working remotely. They may ask that project information be emailed to them. Expect delays but TPS review process is moving forward.

The National Register nominations listed from 1966-2012 are now online at the National Archives and Record Administration's (NARA) Electronic Records Archive (ERA). Scanned by the Western Archaeological and Conservation Center (WACC) of the National Park Service, the electronic nominations are now available to the public online at https://catalog.archives.gov or can be reached by utilizing the National Register guides online at

https://www.nps.gov/subjects/nationalregister/database-research.htm. In the future, the National Register nominations will be permanently held at the National Archives and available online for researchers, excepting those restricted nominations that are withheld from public distribution under the authority of Section 304 of the National Historic Preservation Act (54 U.S.C. §307103). Plans call for the National Register program to soon provide scanned copies of National Register documentation for properties listed from 1913 through 1918 to the National Archives.

Klondike Gold Rush National Historical Park is hiring a GS-11 permanent (subject to non-pay) Archaeologist with a focus on historic archaeology.

The park, designated to commemorate the Klondike Gold Rush on 1897-99, has a broad collection of historic sites including homesteads and business spaces in Skagway, AK; the now-abandoned boom towns of Dyea and White Pass City, AK; the Chilkoot Trail; and pieces of the White Pass Trail.

**Annual Grants**: The National Trust for Historic Preservation is accepting applications for its annual grants program. The funding ranges from \$2,500 to \$5,000 and supports preservation planning and educational projects. Application deadlines are June 1 and October 1. The National Trust reports that past grant projects have included engineering and architectural consulting services; tours that are accessible via smart devises; and market studies to assist in prioritizing preservation objectives.
