The Alaska SHPO has invoked tolling effective March 19, 2020 regarding the timelines outlined in 36 CFR 800. With tolling, the 30-day regulatory clock that would allow agencies to proceed with their undertaking following non-response after 30 days does not apply. SHPO will be allowed to comment beyond the 30 days.

### Division of Libraries, Archives, and Museums news

The Division of Libraries, Archives, and Museums is recruiting participants for a new training program. *Preparing Alaska’s Cultural Organizations for Emergencies* (PACO) is open to staff or volunteers from institutions with original humanities materials. *Underrepresented Community Grant Program* – applications due March 31, 2021

The URC grant projects include surveys and inventories of historic properties associated with communities underrepresented in the National Register, as well as the development of nominations to the National Register for specific sites. The National Park Service's proposed rule changes to the National Register process submitted by the Trump Administration to the Office of Information and Regulatory Affairs (OIRA), has been halted. The Biden Administration is expected to promulgate a new rule that is consistent with the intended purpose of the 2016 amendment which requires SHPOs to weigh in on National Register nominations on federal land.

## Advisory Council on Historic Preservation news

The ACHP Chair Aimee Jorjani resigned following a request from President Biden. A 2016 amendment to the National Historic Preservation Act made the chair a full-time Senate confirmed position. The selection of a new executive director was also canceled. Former ACHP executive director John Fowler is serving part time as executive director until his replacement is hired. ACHP Vice Chairman Rick Gonzales will carry out the functions of the chairman while the position of chairman is vacant.

The ACHP submitted their triennial report on the status of federal preservation, *In a Spirit of Stewardship: A Report on Federal Historic Property Management*, to President Biden. The report is required under Preserve America every three years for agencies that manage federally owned historic properties. The report summarizes the state of the federal government's inventory on historic properties, examines issues surrounding to their management, how they relate to important issues facing the country like jobs, infrastructure, and resiliency, and recommendations to address current concerns in federal preservation practice. The Advisory Council on Historic Preservation and the U.S. Department of Housing and Urban Development (HUD) are seeking nominations for the ACHP/HUD Secretary's Award for Excellence in Historic Preservation. The award was created to encourage agencies, developers, and organizations to nominate projects or activities that advance the goals of historic preservation while providing affordable housing and/or expanded economic opportunities for low- and moderate-income families and individuals. On April 3, 2020, the Advisory Council on Historic Preservation issued a blanket extension regarding the review under 36 CFR 800.12 of undertakings responding to COVID-19 emergency and disaster declarations. Considering the likelihood of such declarations remaining in place into the foreseeable near future, and the ongoing need for federal agency responses to them, that extension is now set to expire on March 31, 2021.

### Housing and Urban Development news

Federal Housing Administration (FHA) has issued a delegation for Lenders to initiate Section 106 consultation under 36 CFR 800.2.(c)(4). The delegation will become effective March 18, 2021.
