**Federal Legislation**

The Biden Administration proposed a budget for Fiscal Year 2022 that funds the Historic Preservation Fund (HPF) at \$151.8 million.

### Office of History and Archaeology and Alaska Historical Commission news

The Office of History and Archaeology's FY2022 (July 2021 -June 2022) state *operating* budget is \$2,688,300 which represents level funding from FY2021. Of the total operating budget \$464,200 is General Fund Match (GFM) and \$16.1 General Fund Program Receipts (GF/PR) is from the Alaska Historical Commission's special publications account (A.S. 41.35.380). The balance of OHA's operating budget \$2,224,100 is "other" funds – federal grants and interagency agreement receipts – and represents *authorization* to receive those funds.

The Governor vetoed the \$200,000 General Fund Match funds for OHA's state *capital* budget with authorization to receive \$600,000 federal National Historic Preservation Funds. The federal HPF funds require a 40% state match.

### Certified Local Governments

The Municipality of Anchorage's Historic Preservation Commission (HPC) has written an ordinance establishing a Local Landmark Registry to recognize the unique cultural and historic resources found throughout the Municipality. The new ordinance was adopted unanimously by the Anchorage Assembly on April 14th. Local landmark registers enable communities to identify, recognize, and preserve their history and culture. To qualify, a resource must be at least 30 years old and have significance in one of the following areas: History, Architecture, Geography, Culture, or be listed in the National or Alaska Landmark Register. If you are interested in nominating a property, the application form and guidelines for completing a nomination packet will be available soon on the HPC's website. The Alaska SHPO has invoked tolling effective March 19, 2020 regarding the timelines outlined in 36 CFR 800. With tolling, the 30-day regulatory clock that would allow agencies to proceed with their undertaking following non-response after 30 days does not apply. SHPO will be allowed to comment beyond the 30 days.

### Division of Libraries, Archives, and Museums

#### Apply to Preparing Alaska's Cultural Organizations for Emergencies

Staff and volunteers at Alaska libraries, archives, museums, and other institutions with original collections materials are encouraged to apply to the PACO program. Participants enroll in a four-month course on comprehensive emergency management for collecting institutions, are paired with an experienced coach who assists with the drafting of an emergency plan, and take part in a 3-day in-person workshop on disaster response. This program is free for participants thanks to the National Endowment for the Humanities. The deadline to apply for Cohort B is August 9. ### Advisory Council on Historic Preservation

**President Biden** [announced](#) his intent to nominate **Sara Bronin** to be Chairman of the [Advisory Council on Historic Preservation](#) (ACHP). If confirmed, she would become the second full-time Chairman of the ACHP, after the position was converted to a full-time, presidentially nominated position in 2016. Bronin is a Mexican-American architect, attorney, and policy maker that specializes in historic preservation, property, land-use and climate change. She's currently a professor at the Cornell College of Architecture, Art and Planning and faculty member at Cornell Law School. She has held visiting positions at the Yale School of Architecture, University of Pennsylvania, and the Sorbonne. Among other scholarly service, Bronin is an elected member of the American Law Institute and a past chair of the State and Local Government Law Section of the American Association of Law Schools. She's published numerous articles and books on historic preservation law. She recently led an [amicus brief](#) on behalf of her native city of Houston, TX in support of their historic preservation ordinance, which was challenged, but upheld by the Texas Supreme Court. She's a current advisor for the [National Trust for Historic Preservation](#), a board member of [Latinos in Heritage Conservation](#), and a past Chair of [Preservation Connecticut](#).

Bronin's nomination would likely come before the Senate Energy and Natural Resources Committee and then be considered by the full Senate for confirmation.

**U.S. Department of Veterans Affairs (VA) "Program Comment for Vacant and Underutilized Properties"**. On October 26, 2018, the Advisory Council on Historic Preservation (ACHP) issued a "Program Comment for Vacant and Underutilized Properties" at the request of the U.S. Department of Veterans Affairs (VA). The Program Comment provides VA with an alternative way to meet its responsibilities under Section 106 of the National Historic Preservation Act (NHPA). The Program Comment enables VA to proceed with certain undertakings following an expedited review process that complements VA's real property priorities in finding uses for its vacant and underutilized properties.

The ACHP is responsible for hosting a publicly accessible web page that features information on the VA Program Comment (<https://www.achp.gov/VA/VAProgramComment>) and, each year upon receipt of the list and narrative from VA, posting the composite list of properties and narrative on that web page and emailing the National Conference of State Historic Preservation Officers (NCSHPO), State Historic Preservation Officers (SHPOs), Tribal Historic Preservation Officers (THPOs), Indian tribes, Native Hawaiian organizations (NHOs), interested Veterans Service Organizations (VSOs), and ACHP members about its availability, along with a reminder about the timeframes outlined below.

**The deadline for requesting additional information, sending comments, and/or providing an objection to VA regarding the properties on the list is Friday, July 30, 2021.**
