Federal Legislation news

The House has passed 5 out of their 12 FY25 appropriations bills, including the <u>House Interior Appropriations Bill</u>. The House Interior Appropriations bill included \$168.9 million for the Historic Preservation Fund (HPF), \$19.76 million below FY24 enacted levels. The Senate Appropriations Committee advanced 11 out of 12 appropriations bills. The <u>Senate Interior Appropriations bill</u> included \$182.775 million for the HPF, \$5.891 million below enacted levels. Both bills included a 1 year authorization for HPF, which is again set to lapse at the end of the month.

Grants

The Notice of Funding Opportunities (NOFO) for NPS FY2024 competitive programs will be spring through fall 2024. To be notified when this year's opportunities become available, go to <u>Grants.gov and subscribe to a saved search</u>: for CFDA 15.929 for Save America's Treasures (SAT), 15.932 for Historically Black Colleges and Universities (HBCU), and 15.966 for all other competitive programs. You can create a saved search on grants.gov under the "Connect" menu. The application period is 60-90 days from the time the NOFO is posted on Grants.gov. Because the window to apply for funding is limited, we encourage all applicants to plan well ahead of the application deadline. Information on applying to all of NPS' competitive programs is available through their website year-round. Registration in Grants.gov, SAM.gov, and other federal systems can take up to four weeks, so start early. Extensions will not be granted due to incomplete registrations in these systems or applications.

NSBP 2024 Grants NOFO Overview Webinar

The Consolidated Appropriations Act, 2023 (Public Law 117-328), enacted on December 29, 2022, appropriated \$20 million, and the Consolidated Appropriations Act, 2024 (Public Law 118-42), enacted on March 8, 2024, appropriated an additional \$7.5 million in Highway Infrastructure Program funds for the NSBP under <u>23 U.S.C. 162</u>. Under 23 U.S.C. 162(b), grants and technical assistance are to be made available to States or Indian Tribes to (a) implement eligible projects on highways designated as National Scenic Byways or All-American Roads (America's Byways®), State scenic byways, or Indian Tribe scenic byways; and (b) plan, design, and develop a State or Indian Tribe scenic byway program.

National Trust for Historic Preservation news

The National Trust for Historic Preservation is now accepting nominations for the <u>2025 list of America's 11 Most</u> <u>Endangered Historic Places</u>.

Since 1988, the National Trust has published an annual list of America's 11 Most Endangered Historic Places to raise awareness about the threats facing some of our nation's greatest treasures. The list, which has identified more than 350 sites to date, has proven so successful in galvanizing preservation efforts that only a handful of sites have been lost.
